 - No visible (lawful) means of support







Background

Each double-page of the registers 1861-1885 is headed "depositions etc received". Under this heading, entry details also vary over time but usually include: number, name of accused, offence for which committed, committing magistrate and bench, place of trial, when, court where the trial was held, witnesses, bail, depositions when received, despatched to, when, judge, verdict, sentence and date of sentence or discharge, and remarks; if a gaol sentence was imposed it gives the name of the gaol. Adjournments are included while applications for leave to appeal are noted in red.

With the information contained in these registers it is possible to look for further information in court and prison records and to locate court transcripts in <u>Series ID 4508</u>.



Court records

Court of Petty Sessions, 1844 - 1965

Courts of Petty Sessions (CPS) were in existence at the time of Separation from the Colony of New South Wales in 1859. The Court held original jurisdiction in minor criminal offences with right of appeal to the District Court. From 1867 the Court could sit as a Small Debts Court, whose functions are described below. The Court could sit as a Police Court and, during the twentieth century, was also the place where a number of other types of court hearings were held such as the Licensing Court, Children's Court, and Coroners Court.

Brief guide 22

The Clerk of the Court of Petty Sessions often acted as agent for State and Federal Government Departments on matters unrelated to the justice system. It is not unusual to find records received from a particular Clerk of the Court of Petty Sessions about non judicial matters.

CPS records at Queensland State Archives date from 1844 however, not all districts are represented. QSA holdings vary in quantity and content. Under the *Justices Act Amendment Act* 1964 the courts known as Courts of Petty Sessions were renamed Magistrates Courts (see below).





These records at Qld State Archives are useful for genealogy, especially if you are researching the 'black sheep' of the family or someone who committed a very minor offence or was a victim of crime.

Police Station watchhouse charge books and Court of Petty Sessions police charge bench books often provide clues to sources for further research (Court, prison and mental asylum records, criminal depositions, murder files, Police Gazettes and other police records, etc.) Although the registers vary in format, most give date, town, prisoner's name, aliases, age, occupation, religion, state or country of origin, education level, offence, and how disposed of (fine or term of imprisonment, or whether sent to a reformatory, asylum etc. or discharged, cautioned, or committed for trial at which court and when). Some show **previous convictions** and prisoner's signature and property, and on rare occasions a physical description. Some victims of crime are named. There are occasional references to **illegitimate children** (I have seen one listing names, addresses and occupations of the child's mother, maternal grandparents and putative father).

Offences include theft, drunk and disorderly, breaking and entering, child (or wife) desertion, having no visible lawful means of support, attempted suicide, being of unsound mind, inciting to riot, beating a horse, assault, murder, supplying opium to an Aboriginal, and being a neglected child. **Children** appear in the records as both offenders and victims.



- In September 1886 Maria summoned Adam for maintenance at Ipswich where he was ordered to pay 10s a week. His brother became surety for him but Adam absconded.
- Maria Johnston and John Bolton arrived in Beenleigh in January 1887 and lived in tents along the Southport railway line.
- In June 1887 Adam Johnston was arrested for disorderly conduct.
- On 24 October 1887 Maria summoned Adam for assault and the following day Adam stole his wife's sewing machine.
- On 3 November 1887 Maria summoned Adam for maintenance and he was advised to pay 12s a week.
- Adam was charged with wife desertion and bound to pay 12s a week and two sureties of £15 each or in default six months imprisonment.
- After he was sent to gaol, Bolton and Maria moved to Pimpama and were living there in January 1888.
- The Rev Mr Martin claimed that Adam was living with another woman and that he was not quite right in his mind.



ESTABLISHMENT:

Under the First and Second Charters of Justice (proclaimed in 1787 and 1814 respectively under the authority of Imperial Act 27 George III) justices of the peace appointed by the Governor were granted summary jurisdiction to hear petty criminal matters in the first instance without a jury.

The powers of justices of the peace and of police magistrates to sit as petty sessions were ultimately codified in the New South Wales Acts of 1835 (2 Victoria 2) and of 1850 (14 Victoria 43). This latter New South Wales Act ultimately formed the basis of the Queensland "Justices Act of 1886", which legislated for the appointment by the Governor in Council of districts for the holding of courts of petty sessions. The Court of Petty Sessions, Forsayth was proclaimed by the Governor in Council on 28 July 1911.

Under the "Justices Act Amendment Act 1964", from 1 January 1965 onwards: all courts of petty sessions districts were deemed to be magistrates courts districts, all places previously appointed for the holding of courts of petty sessions were deemed to be places for the holding of magistrates courts, all clerks of petty sessions were deemed to be registrars of magistrates courts.

FUNCTIONS

Under a number of further Acts, the establishment of a place for the holding of a court of petty sessions was deemed to establish a number of further courts, for example, magistrates courts, fair rents courts, small debts courts. This agency definition will however be concerned purely with the court of petty sessions sitting as this court.

Courts of petty sessions had petty criminal jurisdiction and jurisdiction for summary actions of ejectment between lessors and lessees. Petty criminal jurisdiction is a complicated matter of law involving numerous Commonwealth and State statutes but can be briefly described as jurisdiction over summary trials of simple offences and committal proceedings for indictable offences sent to the Supreme Court.

In practice, if not in statute, courts of petty sessions were divided into three courts: police court (prosecutions commenced by police), summons court (prosecutions and proceedings for ejectment commenced by private prosecutors) and traffic court.





ALLEGED ARSON CASE.

At the South Brisbane Police Court yesterday, before Mesers. W. Yaldwyn. P.M., T. Austin, and R. Alien, JJ.P., & middle-aged man named John Finn appeared in custody charged with wilfully and unlawfully setting fire to a dwellinghouse in Hampstead-street, Woolloongabba, last Sunday merning. Sab-impector Geraghty conducted the prosecution. Constable Coman stated that at about 7.30 on the morning of the 30th metant he saw defendant in Balaciava-otreet, Woolloongabba, when he said to him, "Where did you sleep last night?" He replied. "Nowhere." Then he said to him, "Where were you last night?" to which he replied, "I was over in town." In answer to further questions he said that he arrived in town from Ipswich "beand 10 yesterday tween He also said that he came over Dg." here soon after dinner time. Witness then asked him how long he remained over here, and he said for a while, after which be went over to meet the balf-past 5 train from Ipswich. Asked him then what time he came back, and he said, "I don't know; it was late; the shops and hotels were closed." Defendant did not know either what time he got bome, and said later on that be slept on Nolan's veranda until he was awakened by the cold, after which he went for a walk round the cometery, and had only just come back. Then asked him if he knew where Hampstead-street was, to which he replied,

"Yes, well." Defendant said that it was about a month ago since he was in the locality referred to, and denied that he was there on Saturday night. Witness then conveyed defendant to the watchhouse, where he charged him with wilfully and unlawfully setting fire to a dwelling in Hampstead-street, Woolloongabba, on the morning of the 30th August. Defendant said, "What! Is it the place I was living in?" Witness said. "Yes." Defendant did not ask any questions. On the application of Subinspector Geraghty, a remand was granted till the 8th instant.

ALLEGED ARSON IN SOUTH BRISBANG.

At the South Brisbane Police Court on Tuesday, before Messrs, W. Yaldwyn, P.M., and J. Austin, J.P., a middle-aged man named John Finn appeared in custody charged, on remand, with wilfully and unlawfully setting fire to a dwelling-house in Hampstead-street, Woolloongabba, on the morning of the 30th August. Mr. B. Papi appeared for defendant, and Sergeant Ryan prosecuted on behalf of the police, Constables Colman and Martin gave evidence as to finding marks of hob-nailed boots on the ground surrounding the house, and to taking plaster of paris casts of the impressions. One of these casts corresponded with the right boot of lefendant. Emily Corrie, a married woman, living next door to the house lately occupied by defendant, and which he is charged with setting fire to, deposed to seeing a man enter the front gate of the property and try to wrench the gate off. He went away, returned, and subsequently went away again. She could not identify the man. During that night a fire occurred in the house next door to her residence. Evidence was also given by Mary Nolan and Mary Pinn, and on the application of the police, defendant was remanded till next Monday.







SCTAS Home

This site was created to publish many of the hidden nineteenth century records of the superior courts of Tasmania. The site begins with the first decisions of the newly established Supreme Court of Van Diemen's Land, which first sat in 1824. We will add to the collection in batches of one historical year at a time.

The cases have been chosen by Stefan Petrow and Bruce Kercher, from the surviving newspaper and archival records of the courts. For a description of our selection and editing policies, see the Introduction.

This site matches the collection of New South Wales cases of the same period, which is online. Our aim is to encourage comparative legal history, to show the many ways in which English law was received, rejected, altered and replaced in the Australian colonies.

News

November 2010: we have now published Alex Castles' index to legal cases in Tasmanian newspapers.

October 2006: we have just published an important 1838 speech by Robinson, Protector of Aborigines.

As at February 2005, we have now put 1843 cases online.

April 2004: we have now published the surviving records of pre-1850 appeals from the Australian colonies to the Privy Council in London. Concentrating on the unreported decisions of the Privy Council, these records are taken from the office of the Judicial Committee of the Privy Council, and from the National Archives in Kew, London.

We have also begun placing further cases online, from the Colonial Times. We have completed these to the middle of 1835, including corrections to the Subject Index.

Thursday, - His Majesty's Attorney-General rose to exhibit an Information against William Kermode [2] and Samuel Hood, Esquires, for having endeavoured to incite William Talbot [3], Esquire, to fight a duel. The first party was charged with having written the challenge, and the other Gentleman was accused of having conveyed it. The Attorney-General then moved, on an affidavit from Mr. Talbot, that the said William Kermode & Samuel Hood, Esquires, might be ordered to attend before the Court *instanter*, and give sureties to keep the peace for 12 months, towards the said William Talbot, Esquire, who was apprehensive of otherwise receiving from them, not only insult, but also injury. A citation, directed to those Gentlemen, was therefore issued, and shortly afterwards they entered the Court; when the Attorney-General took occasion to express his confirmed regret, that any cause for the present proceedings should exist, -that misconceptions should create wrath, -- and that wrath should seek its pleasure in the violation of law. But it was his solemn duty to guard the public peace, and he trusted he never should be found neglectful of it, however high in society those might rank, against whom it might be necessary for him to act. - It was on oath that the Gentlemen cited, and now standing before that Court, had done an act which directly infringed the laws of both their country and God; which likewise tended to bereave all private discourse of toleration. and enkindle the fires of discord in a community, which being small, might, he thought, be entirely united and amicable. He therefore considered himself bound to require the recognizance of each accused party, to appear and plead to the said information, in the sum of £500, and surety from each to the amount of £1000, to keep the peace towards the said William Talbot, Esquire, during 12 months. On these being furnished, the parties withdrew.


